Cigar Locker and Club Membership Contract

Membership agreement details and benefits:

- Club membership is offered monthly at \$200.
- Member will receive \$150 gift card monthly once membership fee is paid.
- Members receive key to private cigar locker which is secure and environmentally controlled for storage of cigars and wine.
- All members will receive 10% off entire bill.
- Members will receive 20% off box of cigars of 20ct or more.
- **MUST PROVIDE MEMBERS CARD FOR REIMBURSEMENT OF GIFT CARD BALANCE.**
- Member gift card does not expire and has unlimited roll over.
- Member will receive any Rocky Patel 10ct Box of cigars on their 1 year anniversary of continuous membership.
- Club members will have access to all **Godfather locations.**
- Members receive discounted rates for **Party Catering.**
- Members receive first option to purchase allocated cigars or limited production products.
- Members will receive discounts at Mezza, Rochester Bistro and American Alpine Lodge in Gaylord. Member card must be present and can't be applied on top of any other house promotions.
- Members must agree to Terms and Conditions as stated on membership application.

Terms and Conditions

As a condition of membership, for the courtesy and safety of the other members, the protection of member's property and the protection of the Godfather Cigar Martini Lounge itself you must agree to the following terms and conditions.

1. I am at least 21 years of age or over.
2. Membership billing occurs on the 1st of the month using valid credit card on file.
3. Credit card authorization form must be signed for monthly automatic renewals to continue membership.
4. I agree to maintain a valid credit card on file upon which the Godfather Lounge may charge for monthly membership renewals on the 1st of each month.
5. I agree to notify Godfather Lounge management about cancelation two week before the 1st of the month to avoid billing.
6. I understand there are NO REFUNDS once membership fee has been charged and processed.
7. I understand if I lose my membership card I will lose all credit on my card as Godfather Cigar Martini Lounge is not responsible for lost cards.
8. I agree on the date of cancelation/termination to return my locker key and clean out my locker. I agree to clean out my locker within 14 days of cancelation/termination or I shall be charged \$100 for the month and The Godfather may take ownership of all and anything in my locker.
9. I agree that a replacement membership ID card is \$25 and replacement keys and lock is \$25 fee plus the cost of a locksmith.
10. I agree to respect and honor the hours of operation as posted on The Godfather cigar martini lounge website, as well as the business hours posted on location.
11. I agree that no outside products will be stored in my locker. I understand that this requirement is for the safety of other members and their respective inventories, protecting all members from exposure to tobacco beetles, blue mold, etc... That might come from other tobacco establishments or poorly maintained home collections.
12. I agree that under no circumstances whatsoever will I bring any illegal products or substance into The Godfather Cigar Martini Lounge, and that any incident involving illegal products or substances will result in termination of membership immediately.
13. I agree there is absolutely **no cigarette smoking** allowed in or on the Godfather Cigar Martini Lounge property and that we are strictly a cigar club.
14. I agree that any violation of the terms of membership may be grounds for termination of membership.
